In the majority of Henderson's Criminal Cases he was sentenced to probation and restitution despite the fact the the court is still trying to collect fees from cases dating back as far as 1997, as shown below.

38-year-old Robert Haynes Henderson was sentenced today in the Gila County Court by Superior Court Judge Robert Duber.

He was sentence to 90 days in the Gila County, but, he wont have to serve that time now if at all. Judge Duber gave him probation, again. If from some point down the road, he is not paying restitution, he could be made to serve that time.

Henderson was arrest on September 2, charged with Theft of means of transportation, trafficking in stolen property, unlawful flight, and possession of stolen property, was in Gila County Superior Court on Monday.

As a part of Plea Agreement Henderson plead guilty to Unlawful Flight from Police, a class 5 felony. The 3 theft charges were dismissed. Henderson could serve up to a year in prison, but could also walk with just probation, again.

Robert Henderson has a long criminal history with over 19 separate case numbers, each with multiple charges for crimes such as Aggravated Assault-Enter Residence, Criminal Trespassing, DUI, Theft, Disorderly Conduct-Fighting, and Leaving the Scene of an Accident.

All of Henderson's charges were brought before the Gila County Justice Court, therefore not subject to prison time, and charges that would have been considered felonies were dismissed, even though he had committed the same crime multiple times in the past.
